# TERMS AND CONDITIONS OF LICENCING

This agreement governs the grant of a licence only under the following conditions.

- 1) Where a person is making this application on behalf of another person ('the applicant'), which can include a partnership, corporation or other entity, the person warrants that they have the authority to enter this agreement on behalf of the applicant.
- 2) Subject to the terms and conditions of this agreement, Crossroad grants to the applicant a non-exclusive conditional licence to:
  - a) Present only the Crossroad controlled VIDEO/DVD which are listed on licence only; and
  - b) Present only in accordance with information supplied on the Licence.
- 3) The grant of the licence is conditional on the applicant:
  - a) Paying Crossroad the licence fee of \$165.00 (including GST) to be included in the final Tax Invoice
  - b) Not screening the video/DVD in a cinema
  - c) Licence is for one year from date on licence and only for the venue stated on licence.
  - d) Charging no admittance fee however collection of donations to cover costs is permissible.
  - e) Accepting the responsibility of abiding by the licence expiry date as noted on the licence.
- 4) Crossroad will supply the applicant with a Tax Invoice that will specify the royalty payable. The applicant will pay in full the royalty specified in the invoice within fourteen (14) days of the date appearing on that invoice ("the Due Date").
- 5) Where the applicant
  - a) Fails to pay Tax Invoice in full by the Due Date; or
  - b) Screens the video/DVD prior to Crossroad receiving payment in full this agreement is automatically terminated.
- 6) If the applicant breaches any other provision of this agreement, Crossroad may terminate this agreement by giving the applicant 14 days written notice.
- 7) Crossroad warrants that it has the right to grant this licence and in the event of a breach of this warranty, the liability of Crossroad is limited to the consideration paid for the licence.
